4. VENDORS MUST REMAIN INSIDE THEIR ASSIGNED SPACE.
5. THE EVENT IS FAMILY BASED. PRODUCTS THAT ARE DEEMED INAPPROPRIATE WILL BE REMOVED.
6. SPACE WILL BE ALLOTTED BY PLANNING COMMITTEE TO BEST UTILIZE SPACE AVAILABLE. BECAUSE OF THIS, PRIOR YEAR VENDORS SHOULD NOT EXPECT TO BE IN THE SAME LOCATION AS LAST YEAR. EVERY EFFORT WILL BE MADE TO KEEP YOU IN THE SAME LOCATION BUT NOTHING WILL BE GUARANTEED.
